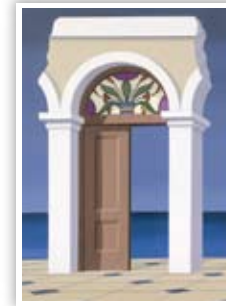


## Firm Profile
